## ARTICLES OF INCORPORATION

OF

## BEAR RIVER LOG HOMES INC.

The undersigned incorporator(s), desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt(s) the following articles of incorporation:

ARTICLE ONE. The name of the corporation is Bear River Log Homes Inc.

ARTICLE TWO. The purposes of the corporation are log home manufacture and sales, and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act or The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE. The period of duration of the corporation is perpetual.

ARTICLE FOUR. The address of the corporation's initial registered office in the State of Idaho is Box 631, City of Driggs, County of Teton, 83422. The name of the corporation's initial registered agent at such address is Roy C. Moulton.

ARTICLE FIVE. The total authorized number of nopar value shares of stock is 500,000.
