ARTICLES OF INCORPORATION
of

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is BOHICA Enterprises, Inc.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are these: the construction and operation of commercial buildings, the development and sale of real property, and all other lawful purposes.

IV.

The aggregate number of shares which the corporation shall have authority to issue is 10,000. All shares are without par value.

V.

The name of the agent of the corporation is DONALD R. SMOCK. The address of the initial registered office of the corporation is 200 Sherman Avenue, Coeur d'Alene, Idaho 83814.

VI.

The number of directors constituting the initial board of directors of the corporation is five, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify, are as follows:

Transfer of shares shall be restricted because this corporation is electing to have the status of a Small Business

Corporation under Subchapter S of the United State Internal Revenue Code (26 U.S.C.A. Section 1361 et seq.).

The shareholder must offer shares to the corporation or to any other holders of shares of the corporation or to any other person or to any combination of the foregoing, a prior opportunity, to be exercised within a reasonable time, to acquire the restricted shares.
