Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, SCIENTECH, Inc. has adopted the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

I.

The name of the corporation is SCIENTECH, Inc.

II.

The following amendment to the Amended and Restated Articles of Incorporation was adopted on August 6, 1993, by the shareholders of the corporation in the manner prescribed by the Idaho Business Corporation Act:

A new Article V is hereby added to the Amended and Restated Articles of Incorporation of SCIENTECH, Inc. to read as follows:

V.

The business of this corporation shall be managed and conducted by a board of directors. A majority of the directors must be present at a meeting to constitute a quorum for the transaction of any business, and the act of the majority of the directors present at a meeting at which a quorum is present shall be the act of the board of directors. Notwithstanding the foregoing provisions of this Article, so long as Lawrence J. Ybarrondo holds a majority of the issued and outstanding shares of the corporation, his act at a meeting at which a quorum is present shall be the act of the board of directors.

III.

1,854,443 shares of the corporation were outstanding at the time of such adoption, and 1,841,156 shares were entitled to vote thereon.

IV.

The number of shares voted for such amendment was 1,836,381 and the number of shares voted against such amendment was 2,333.

V.

Such amendment does not affect a change in the amount of stated capital.
