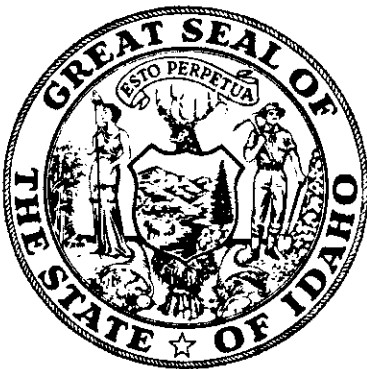

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being the President and Secretary respectively and constituting a majority of the Board of Directors of the Idaho corporation Western Recycling & Waste Paper Corporation do hereby make, sign, acknowledge, file and adopt for the purposes of voluntarily dissolving this corporation pursuant to Idaho Code Section 30-1-92 the following:

ARTICLE I

The duly registered and adopted name of the corporation is Western Recycling & Waste Paper Corporation whose address is 1990 South Cole, Boise, Idaho 83709.

ARTICLE II

David J. Dean, Luane Dean and Peggy Dean constitute the Board of Directors of the corporation with David J. Dean being the President, Luane Dean being Vice-President and Peggy Dean being Secretary-Treasurer.

ARTICLE III

The notice requirement as set forth in Idaho Code Section 30-1-87 has been fulfilled. All debts, obligations and liabilities of the corporation have been paid and discharged or adequate provision has been made therefor.

ARTICLE IV

All remaining property and assets of the corporation have been distributed in accordance with the distribution provision in the Articles of Incorporation or in accordance with the Plan of Complete Liquidation adopted by the corporation whereby all assets and debts of the corporation are being distributed to the corporation's sole shareholder, Future Enterprises, Inc.

ARTICLE V

There are no suits pending against the corporation in any court.

ARTICLE VI

This dissolution has received the unanimous written consent of the sole shareholder of the corporation as allowed by Idaho Code Section 30-1-83. The last officers and directors of the corporation are David J. Dean, President, and Peggy Dean, Secretary-Treasurer, whose address is 1990 S. Cole, Boise, Idaho.

ARTICLE VII

This dissolution is done pursuant to a Plan of Complete Liquidation adopted by the corporation in order to liquidate in conformity with Section 332 and 337 of the Internal Revenue Code of 1986, as amended.
