

ARTICLES OF INCORPORATION

0f

STROM, LONGETEIG & JOHNSON, CHARTERED

The undersigned, each of whom is a duly licensed attorney in the State of Idaho, desire to form a professional corporation pursuant to Title 30 Idaho Code, Chapter 1301 et seq., for the purpose of rendering legal services, and adopt the following articles of incorporation for such corporation.

ARTICLE ONE Name

The name of the corporation shall be Strom, Longeteig & Johnson, Chartered.

ARTICLE TWO Purpose and Powers

The purpose for which the corporation is formed is to engage in the general practice of law.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts to the extent permitted under Title 30, Idaho Code, Chapter 1301 et seq.

ARTICLE THREE Principal Office

ARTICLE SIX Capitalization

The duration of the corporation shall be perpetual.
