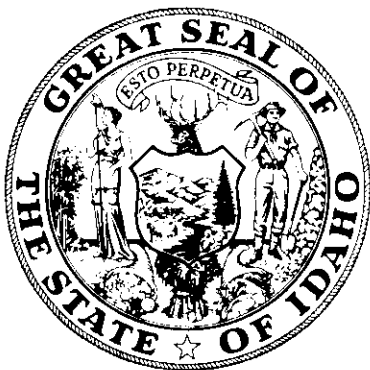

ARTICLES OF INCORPORATION
OF
A.E.B. PUBLISHING COMPANY, INC.

The undersigned, acting as incorporator of the corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is A.E.B. Publishing Company, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act including but not by way of limitation the purpose of entering into the business of publishing a periodical magazine.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1000 shares with no par value.

FIFTH: The address of the initial registered office of the corporation is Suite 1405, Idaho First Plaza, Boise, Idaho, 83702, and the name of its initial registered agent at such address is Owen H. Orndorff.

SIXTH: The number of Directors constituting the initial Board of Directors of the corporation is three and the names and addresses of the persons who are to serve as Directors until the first annual meeting of Shareholders or until their successor is elected and shall qualify are:

SEVENTH: The name and address of the incorporator is David R Craig, P.O.Box 7823, Boise, Idaho 83702.

EIGHTH: Amendment of the By-Laws of the corporation by the Board of Directors shall require majority approval of those Directors present either in person or by proxy at a meeting of the Board of Directors duly called at which a quorum is present.

NINETH: The Board of Directors may create such committee or committees as it deems to be necessary or advisable with only such power and authority as is specifically defined in the resolution establishing such committee.

TENTH: The Articles of Incorporation shall not be removed, modified or amended except upon approval of a majority of all of the Shareholders at a regular or special meeting of the Shareholders called for such meeting.
