ARTICLES OF INCORPORATION  
OF  
RE'-IDA, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following ARTICLES OF INCORPORATION for such corporation:

ARTICLE I.

The name of the corporation is RE'-IDA, INC..

ARTICLE II.

The duration of the corporation shall be perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized is to generally conduct agricultural business which shall include, but not be limited to, sowing, growing and marketing certified seed potatoes, and to generally, without limitation, engage in and undertake all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is FIVE HUNDRED (500) shares of common stock with no par value.

ARTICLE V.

There shall be no provisions denying pre-emptive rights of shareholders.

ARTICLE VI.

Provisions for the regulation of the internal affairs of the corporation are:

1. All decisions of the shareholders or the Board of Directors shall be by a majority of a valid quorum as defined by the bylaws.
2. The Board of Directors shall serve without compensation; however, this shall not prevent members of the Board of Directors from being reimbursed for reasonable and necessary expenses expended on behalf of the corporation which were either approved in advance by the Board of Directors, or ratified by the Board of Directors after the fact; however, this shall not be construed so as to prevent the corporation from hiring a member of the Board of Directors as an employee and compensating him for such services.

The number of directors constituting the initial Board of Directors of the corporation is four (4). The number of directors may be altered by the bylaws or by amendment to the bylaws. 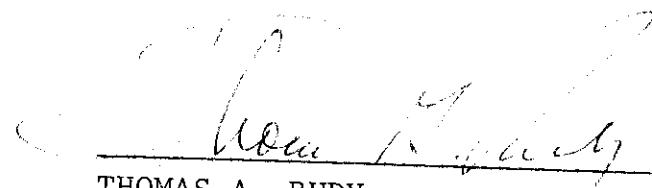
