ARTICLES OF INCORPORATION  
OF  
BONNERS FERRY PEACE OFFICERS ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, whose names are hereto affixed, all of whom are bona fide residents and full-age citizens of the United States of America, do under and in pursuance of Idaho Code 30-3-1 et seq. as amended, and general corporation laws of said State, hereby organize, constitute and associate ourselves in accordance with these Articles, into a body politic, and corporate for the purposes hereinafter set forth and to that end we execute these Articles of Incorporation, and hereby certify, set forth and declare as follows:

I.

NAME

The name of the corporation is:

BONNERS FERRY PEACE OFFICERS ASSOCIATION, INC.

II.

PURPOSE

This corporation is organized, and at all times hereafter shall be operated exclusively for charitable, scientific or education purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, and more specifically this corporation is organized, and at all times hereafter shall be operated exclusively for the benefit of the City of Bonners Ferry Police Department, with its principal place of business in Bonners Ferry, Idaho. programs on behalf of the City of Bonners Ferry Police Department and shall be empowered to receive donations of every nature for the City of Bonners Ferry Police Department. This corporation shall administer funds thus received and disburse them, or the income therefrom where endowment funds are received, to the City of Bonners Ferry Police Department, all in a manner responsive to the needs of the City of Bonners Ferry Police Department specifically, but not limited to:

1) purchase of equipment for employees of the Bonners Ferry Police Department when such equipment is not provided by the City of Bonners Ferry;

2) purchase of physical fitness equipment to outfit a mini-gymnasium for use by employees of the Bonners Ferry Police Department for physical fitness activities

3) purchase of Soft Body Armor and other needed equipment to outfit reserve officers when such equipment is not provided by the City of Bonners Ferry.

The purposes specified herein shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation; nor shall the expression of one thing be deemed to exclude another, although it be of like nature not expressed.

To do all and every thing necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects and purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.


This organization is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.


Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law); or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provisions of any future United States Revenue law).

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or corresponding Section of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of the First Judicial District of the State of Idaho, in and for the County of Boundary, in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which is organized and operated exclusively for such purposes.
