

CERTIFICATE OF INCORPORATION

OF

BLAINE COUNTY, KETCHUM, HAILEY, SUN VALLEY  
AND BELLEVUE CIVIC ASSOCIATION, INC.

Under Section 30-301 of the Idaho Nonprofit Corporation Act

The undersigned for the purpose of forming a corporation under  
Section 30-301 of the Idaho Nonprofit Corporation Act hereby certifies:

1. Name. The name of the Corporation is Blaine County,  
Ketchum, Hailey, Sun Valley and Bellevue Civic Association, Inc.

2. Exempt Status. The Corporation is constituted so as to  
attract substantial support from contributions, directly or indirectly,  
from a representative number of persons in the community in which it  
operates and has not been formed for pecuniary profit or financial gain,  
and no part of the assets, income or profit of the Corporation is dis-  
tributable to, or enures to the benefit of, its directors or officers  
except to the extent permitted under the Idaho Nonprofit Corporation  
Act. No substantial part of the activities of the Corporation shall be  
the carrying on of propaganda, or otherwise attempting, to influence  
legislation, and the Corporation shall not participate in, or intervene  
in, (including the publishing or distribution of statements) any politi-  
cal campaign on behalf of any candidate for public office. Notwith-  
standing any other provision of this certificate, the Corporation shall  
not carry on any other activities not permitted to be carried on (a) by  
a corporation exempt from Federal income tax under Section 501(c)(3) of  
the Internal Revenue Code of 1954 (or the corresponding provision of any  
future United States Internal Revenue Law) or (b) by a corporation,  
contributions to which are deductible under Section 170(c)(2) of the  
Internal Revenue Code of 1954 (or the corresponding provision of any  
future United States Internal Revenue Law).

1                   3.   Purposes.   The purposes for which the Corporation is to  
2   be formed are for educational, civic and charitable purposes within the  
3   meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, and  
4   in this connection, to exercise, promote and protect the privileges and  
5   interests of the residents of the City of Ketchum, City of Hailey, City  
6   of Sun Valley, City of Bellevue, Idaho and all persons residing in  
7   Blaine County whether or not they reside within municipalities; to  
8   foster a healthy interest in the civic affairs of the community; to  
9   develop good citizenship; and to inquire into civic abuses and to seek  
10  reformation thereof. Further, to act in the public interest and to  
11  secure by lawful means greater economy and efficiency in government; to  
12  stimulate the public interest in civic affairs; to affect reduction in  
13  taxes; to endeavor to carry out these purposes and to carry out neces-  
14  sary reforms that are in the public interest. Further, to exercise,  
15  promote, and protect the privileges and interests of the residents and to  
16  foster a healthy interest in the political and civic affairs of the  
17  community; to establish a center of work and interest in order to  
18  cultivate knowledge of local politics; to improve and promote friend-  
19  ship and sociability within the County of Blaine, State of Idaho. To  
20  the ends in this paragraph described, to take and hold by bequest,  
21  gift, grant, purchase, lease or otherwise, any property, real, personal,  
22  tangible or intangible or any undivided interest therein without limita-  
23  tion as to amount or value; to sell, convey, or otherwise dispose of any  
24  such property and to invest and deal with the principal or the income  
25  thereof in such manner as in the judgment of the Director or Directors,  
26  will best promote the purpose of the Corporation and the Blaine County,  
27  Ketchum, Hailey, Sun Valley and Bellevue Civic Association, Inc., with-  
28  out limitation, except such limitations if any as may be contained in  
29  the instrument under which such property is received, this Certificate  
30  of Incorporation, the Bylaws of the Corporation or any laws applicable  
31  thereto. To do any other act or thing incidental to or connected with  
32  the foregoing purpose or an advancement thereof, but not for the pecuniary  
profit or financial gain of its Director or Officers except as is permitted

1 under the Idaho Nonprofit Corporation Act. In furtherance of its cor-  
2 porate powers, the Corporation shall have all general powers enumerated  
3 in Idaho Code 30-307.

4 4. Duration. The duration of this nonprofit corporation is  
5 perpetual.

6 5. No Membership. This nonprofit Corporation shall have no  
7 members.

8 6. The address of the initial registered office of the  
9 Blaine County, Ketchum, Hailey, Sun Valley and Bellevue Civic Association,  
10 Inc. and the name of its initial registered agent at such address is as  
11 follows: Lois M. Hurtig, Sun Valley, Idaho.

12 7. Number of Directors. One director shall constitute the  
13 initial Board of Directors. The Corporation is entitled to have a Board  
14 of Directors composed of nine persons.

15 8. Incorporators. The name and address of the incorporator  
16 of this nonprofit Corporation is: Lois M. Hurtig, Sun Valley, Idaho.

17 9. Officers. Pursuant to Idaho Code 30-318, this nonprofit  
18 Corporation shall have no officers.

19 10. Names of Directors. The names and residences of the  
20 Directors until the First Annual Meeting are:

23 11. Distribution on Dissolution. In the event of dissolution,  
24 all of the remaining assets and property of the Corporation shall, after  
25 necessary expenses thereof, be distributed to such organizations as shall  
26 qualify under Section 501(c)(3) of the Internal Revenue Code of 1954 as  
27 amended.


28 12. Income and Distribution. No part of the income of the  
29 Corporation shall enure to the benefit of any member, trustee, director,  
30 officer of the Corporation or any private individual (except that reason-  
31 able compensation may be paid for services rendered to or for the Cor-  
32 poration affecting one or more of its purposes), and no member, trustee,

1 officer of the Corporation or any private individual shall be entitled  
2 to share in the distribution of any of the corporate assets on dissolu-  
3 tion of the Corporation.

4 13. Prohibited Activity. No part of the activities of the  
5 Corporation shall be carrying on propaganda, or otherwise attempting to  
6 influence legislation, or participating in, or intervening in (including  
7 the publication or distribution of statements), any political campaign  
8 on behalf of any candidate for public office.


