BE IT KNOWN, that we, the undersigned, President and Secretary, respectively, of DR. COPPLE-DR. PECORA-DR. TILDEN, P.A., do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

1. That a special meeting of all of the shareholders of the issued and outstanding stock of DR. COPPLE-DR. PECORA-DR. TILDEN, P.A., was held at the offices of the corporation at 100 Warm Springs Avenue, Boise, Idaho, at 1:00 o'clock p.m., on the 17th day of February, 1978, pursuant to call and waiver of notice and consent, at which meeting all of the issued and outstanding common stock was represented in person or by proxy.

2. That at said meeting, the following resolution was submitted, and upon being put to a vote was unanimously adopted by the unanimous vote of all of the issued and outstanding capital stock of the corporation, to-wit:
