**ARTICLES OF INCORPORATION  
OF

The Undersigned, acting as incorporator of a corporation under the Idaho Business Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is "Tri W Ag Marketing Co."

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:  
development and marketing of food products, together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-301.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand shares of \$100 par value common stock. The shares of the corporation shall consist of a single class -- voting common.

FIFTH: The corporation elects to have full pre-emptive rights as to issuance of stock, as provided under the Idaho Business Corporation Act, Section 30-1-630.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, adopted pursuant to the Idaho Business Corporation Act, Section 30-1-206, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-627.
