ARTICLES OF INCORPORATION

OF

BETTY AND DON'S MUSIC, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be Betty and Don's Music, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is Route 9, Box 61, Caldwell, Idaho 83605, and the name of the initial registered agent at such address is Salli Christensen.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows: retail music business and other legal business, and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

That the total authorized number of par value shares of this corporation shall be one hundred thousand (100,000), each of a par value of five cents (\$.05), and of the aggregate par value of five thousand dollars (\$5,000.00), which said shares shall be common stock and shall not be subject to assessment.
