ARTICLES OF INCORPORATION

Article I

NAME

The name of the Corporation is: DOVE INCORPORATED

Article II

PURPOSE

The purpose or purposes for which the Corporation is organized is to transact all lawful business for which Corporations may be organized under the Idaho Business Corporations Act (Business, Nonprofit and Professional Corporation Laws with amendments through the 1986 Legislative Session).

The Corporation more specifically, but not limited to, is also organized to carry on and conduct a holding company as follows: To purchase, subscribe for, or otherwise acquire and own, hold, use, sell, assign, transfer, mortgage, pledge, exchange, or otherwise dispose of real and personal property of every kind and description, including shares of stock, bonds, debentures, notes, evidences of indebtedness, and other securities, contracts, or obligations of any corporation or corporations, association or associations, domestic or foreign, and to pay therefor in whole or in part in cash or by exchanging therefor stocks, bonds, or other evidences of indebtedness or securities of this or any other corporation, and while the owner or holder of any such real or personal property, stocks, bonds, debentures, notes, evidences of indebtedness or other securities, contracts, or obligations, to receive, collect, and dispose of the interest, dividends and income arising from such property, and to possess and exercise in respect thereof, all the rights, powers and privileges of ownership, including all voting powers on any stocks so owned.

To aid either by loans or by guaranty of securities or in any other manner, any corporation, domestic or foreign, any shares of stock, or any bonds, debentures, evidences of indebtedness or other securities whereof are held by this corporation or in which it shall have any interest, and to do any acts designed to protect, preserve, improve, or enhance the value of any property at any time held or controlled by this corporation or in which it at that time may be interested.

Article III

SHARES

The total authorized stock is 100,000 common shares of no par value per share.
