

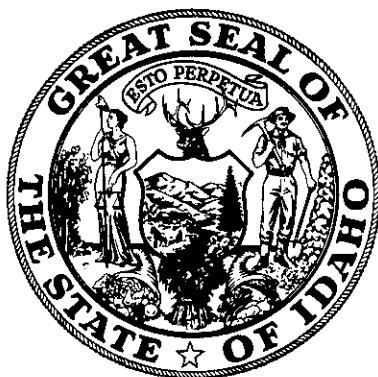
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENCE: That we, Thomas H. Row, Hye S. Row, and Charles G. Row, each of whom are residents of, and citizens of the United States, do hereby associate ourselves together for the purpose of forming a corporation under the general incorporation laws of the State of Idaho, and do make, execute, and adopt in duplicate, the following Articles of Incorporation, to wit:

ARTICLE I

The name of the corporation shall be T BAR R, Inc.

ARTICLE II

The principle place of business and the registered post office of the corporation shall be 11050 Kuna Rd. East, Kuna, Idaho, 83634. The name of the registered agent at this address is Thomas H. Row.

ARTICLE III

The object and purpose for which this corporation is formed is as follows: Any and all legal acts to own, lease, operate, rent, manage, sell, install and maintain electronic equipment for consumer and commercial markets including but not limited to, any and all functions incident to any of the above and in addition, to own, lease, rent, operate and manage electronic equipment together with like equipment and all incidents relating thereto, together with any and all things reasonable and necessary and in furtherance of the objectives of the corporation.

ARTICLE IV

The period of duration for the corporation shall be perpetual.

ARTICLE V

The number of shares of stock which the corporation shall have the authority to issue shall be 100 shares. These shares will be one class and all of such shares are without par value.


ARTICLE VI


