**ARTICLES OF INCORPORATION  
of  
NEW LIGHT ENTERPRISES, INC.**

**ARTICLE I  
NAME**

The name of the Corporation is New Light Enterprises, Inc.

**ARTICLE II  
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III  
PURPOSE**

The Corporation is organized for any lawful purpose.

**ARTICLE IV  
CAPITAL STOCK**

The Corporation is authorized to issue 1,000,000 shares of no-par value common stock, which shall be designated "Common Shares."

**ARTICLE V  
PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any additional stock of the Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI  
INITIAL BOARD OF DIRECTORS**

The Corporation shall have eight directors initially. The number of directors may be increased or diminished from time to time by the Bylaws, but shall never be fewer than two (2). The following initial directors shall serve as directors until the first annual meeting of shareholders or until their successors be elected and qualify:

AMENDMENT**

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the shareholders of the Corporation.

**ARTICLE XI  
AUTHORITY**

Dr. Hanchuan Wang, Rev. Ron Warren and Jim Flecker shall each have authority to establish initial banking relationships on behalf of the corporation.
