
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

BLASS BROTHERS PRODUCE, INC.

4 The undersigned, acting as incorporators of BLASS
5 BROTHERS PRODUCE, INC., a corporation under the Idaho Business
6 Incorporation Act, adopt the following Articles of Incorporation
7 for such corporation:

8 FIRST: The name of the corporation is BLASS BROTHERS
9 PRODUCE, INC.

10 SECOND: The period of its duration is perpetual.

11 THIRD: The purpose or purposes for which the corpo-
12 ration is organized are:

13 (A) To conduct and carry on the business of buying,
14 selling, packing and dealing in all kinds of farm produce, and
15 farm products, livestock and provisions, and all other kinds of
16 goods, wares, and merchandise, and to do a general commission
17 and brokerage business in any or all of the foregoing kinds of
18 property.

19 (B) To carry on any other kind of business or busi-
20 ness activities that the Board of Directors may from time to
21 time deem to be advisable or proper in connection with the
22 business.

23 (C) To purchase, lease, own, sell, mortgage, sublease,
and otherwise acquire lands, buildings, easements or property,

1 real and personal, which may be requisite for the purposes or
2 are capable of being conveniently used in connection with any
3 of the objects of this corporation, and to enter into, make,
4 perform and carry out contracts of every sort and kind with any
5 person, and to acquire and take over the good will, property,
6 rights, franchises and assets of every kind and the liabilities
7 of any person, firm, association, or corporation, either wholly
8 or in part, and to pay for the same in cash, stocks or bonds of
the corporation, or otherwise.

9 (D) To transact any and all lawful business for which
10 corporations may be incorporated under the Idaho Business Corpo-
11 ration Act.
