I, J. D. (CY) PRICE, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

JEWISH COMMUNITY CENTER CORPORATION

was filed in the office of the Secretary of State on the **third** day of **June** A. D. One Thousand Nine Hundred **Forty-Seven** and is duly recorded on Film No. **10** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Pocatello** in the County of **Bannock**, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION

OF

JEWISH COMMUNITY CENTER CORPORATION.

1 KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, whose
2 names are hereunto subscribed, all of whom are bona fide residents of the
3 State of Idaho, and over the age of twenty one years, do, under and pursuant
4 to the provisions of Chapter 11, Section 29, I. C. A., 1932, as amended,
5 associate ourselves together for the purpose of becoming a body corporate,
6 and do now and hereby execute these Articles of Incorporation of JEWISH
7 COMMUNITY CENTER CORPORATION; and do hereby certify:

8 I.

9 That the name of this corporation shall be "JEWISH COMMUNITY CENTER
10 CORPORATION."

11 II.

12 The purposes for which this corporation is formed are:

13 To promote, conduct and maintain all interests of the people of
14 Hebrew extraction in the community in a religious, civic and material manner;
15 to provide housing and administration for religious worship; to provide and
16 carry out plans for rehabilitation of all people of Hebrew extraction; and,
17 in order to properly prosecute the objects and purposes above set forth, the
18 corporation shall have full authority to own, buy, sell, lease and otherwise
19 convey all kinds of property, both real and personal, and securities; and to
20 do each, all and everything necessary for the successful prosecution of the
21 objects and purposes for which the corporation is created.

22 III.

23 That the term for which said corporation is to exist is perpetual.

24 IV.

25 That the office of said corporation in the State of Idaho shall be
26 located at Pocatello, in the County of Bannock, State of Idaho, and that the
27 business address of said corporation in the State of Idaho is Pocatello, Idaho

28 V.

29 The corporate power and business shall be exercised and controlled
30 by a Board of seven Directors.

VI.

That there is no authorized capital stock, as this corporation is formed pursuant to the provisions of Section 29-1101, I. C. A., 1932, and pecuniary profit is not the object of such corporation, but that membership thereof shall be had, and that the price of such membership shall not exceed the sum of \$ per member per year, to be evidenced by issuance of Certificates of Membership.

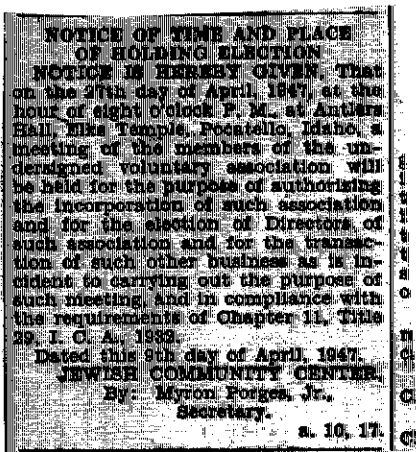


