ARTICLES OF INCORPORATION

<u>OF</u>

JEWISH COMMUNITY CENTER CORPORATION.

** KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, whose names are hereunto subscribed, all of whom are bona fide residents of the State of Idaho, and over the age of twenty one years, do, under and pursuant to the provisions of Chapter 11, Section 29, I. C. A., 1932, as amended, associate ourselves together for the purpose of becoming a body corporate, and do now and hereby execute these Articles of Incorporation of JEWISH COMMUNITY CENTER CORPORATION; and do hereby certify:

I.

That the name of this corporation shall be "JEWISH COMMUNITY CENTER CORPORATION."

II.

The purposes for which this corporation is formed are:

To promote, conduct and maintain all interests of the people of Hebrew extraction in the community in a religious, civic and material manner; to provide housing and administration for religious worship; to provide and carry out plans for rehabilitation of all people of Hebrew extraction; and, in order to properly prosecute the objects and purposes above set forth, the corporation shall have full authority to own, buy, sell, lease and otherwise convey all kinds of property, both real and personal, and securities; and to do each, all and everything necessary for the successful prosecution of the

objects and purposes for which the corporation is created.

That the term for which said corporation is to exist is perpetual.

IV.

That the office of said corporation in the State of Idaho shall be located at Pocatello, in the County of Bannock, State of Idaho, and that the business address of said corporation in the State of Idaho is Pocatello, Idaho

V.

The corporate power and business shall be exercised and controlled by a Board of seven Directors.

That there is no authorized capital stock, as this corporation is formed pursuant to the provisions of Section 29-1101, I. C. A., 1932, and pecuniary profit is not the object of such corporation, but that membership thereof shall be had, and that the price of such membership shall not exceed the sum of \$ per member per year, to be evidenced by issuance of Certifi-
