**ARTICLES OF INCORPORATION**

**WHITE HORSE MINISTRIES, INC.**

The undersigned, acting as incorporator of a nonprofit corporation organized under and pursuant to the Idaho Non-Profit Corporation Act, Title 30, Chapters 21 and 30, Idaho Code, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**Name**

The name of the Corporation (herein "organization" or "corporation") is **WHITE HORSE MINISTRIES, INC., an Idaho non-profit corporation.**

**ARTICLE II**

**Purpose**

The Corporation is a non-profit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

The primary purpose for which this corporation is formed is to provide for a Christian Ministries Service, which shall share its message by live media broadcast, via radio and television and other such media distribution methods and applications, such as books, magazines, CDs and DVDs.

**ARTICLE III**

**Registered Agent**

The address of the initial registered office is 850 Hoop Loop Rd., Priest River, ID 83856, and the name of the initial registered agent at this address is Timothy Saxton.

**ARTICLE IV**

**Board of Directors**

The affairs of the corporation shall be managed by its Board of Directors. The number of Directors serving on the Board of Directors shall be fixed in accordance with the Corporation's Bylaws, but shall not be less than three (3) following the initial Directors meeting. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected by the Corporation in the manner, and for the term provided in the Bylaws of the Corporation.
