



The undersigned, acting as incorporator(s) of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Mountain West Maintenance, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The total authorized number of par value shares of common stock is 100,000 shares, with par value of \$1.00 per share.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are provided in the By-laws of the corporation.

ARTICLE VI

Shareholders of the corporation shall have preemptive rights in the issuance of treasury stock of the corporation, as determined from time to time by the Board of Directors.

ARTICLE VII

The address of the initial registered office of the corporation is 1110 Call Creek Road, Suite 900, Pocatello, Idaho, and the name of the registered agent at such address is P. Bruce Palmer.

ARTICLE VIII
