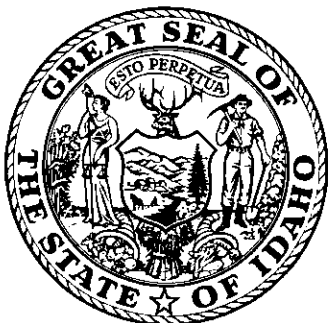

Dear Ms. Martinez:

The Idaho Department of Finance (Department) received your letter dated August 20, 2007, requesting permission to open a loan production office (LPO) in Driggs, Idaho, and to use its current name for the proposed LPO.

There is no requirement for a financial institution to file an application to establish an LPO in Idaho; however, the primary caveat to an institution that intends to operate an LPO is the prohibition against soliciting or accepting deposits. Such deposit activity constitutes conducting banking business under the Idaho Bank Act and would require a bank or branch charter. We understand from your letter that Rocky Mountain Bank (the Bank) is an FDIC-insured, Wyoming state-chartered bank that intends to solicit and provide other services for consumer, real estate, and commercial loans in Idaho. Since the Bank will not engage in deposit-taking or other banking activities in Idaho before its application for an Idaho de novo charter is approved, the Department has no objection to the establishment of the LPO.

Furthermore, the Idaho Bank Act, Idaho Code § 26-1202, prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather the Department is offering "no objection" to your company's use in Idaho of the name Rocky Mountain Bank. Under the circumstances set forth above, we do not believe the company's name is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.

Additionally, for those proposed lending activities that you have described, the Bank is exempt from the requirements of the Idaho Residential Mortgage Practices Act, pursuant to Idaho Code § 26-3103(6), and the Idaho Escrow Act, pursuant to Idaho Code § 30-905(2). Furthermore, as a "supervised financial organization," the Bank is also exempt from licensing provisions of the Idaho Credit Code as set forth in Idaho Code § 28-46-301(2), but is subject to the substantive provisions of the Idaho Credit Code.
