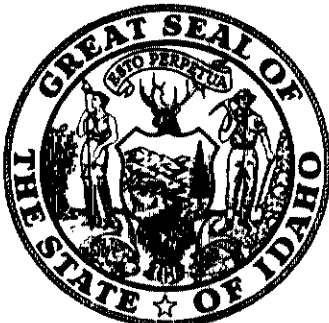
### CERTIFICATE OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the laws of the State of Idaho, do hereby adopt the following articles of incorporation.

ARTICLE ONE  
NAME

The name of the corporation is G&R Enterprises, Inc.

ARTICLE TWO  
CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE THREE  
PURPOSE OR PURPOSES

The purpose for which it is formed is to engage in any lawful business, contract or undertaking for which corporations formed under the laws of the State of Idaho may engage and, in connection therewith, to exercise all express and incidental powers normally permitted such corporations.

ARTICLE FOUR  
CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is Five Thousand (5,000). Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.
