## ARTICLES OF INCORPORATION

CUSHMAN MECHANICAL, INC.

We, the undersigned, being natural persona of the age of twenty-one

(21) years or more, acting as Incorporators of a corporation under the

Corporation laws of the State of Idaho, as amended, hereby adopt the following

Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Cushman Mechancial, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

The transactions of any or all lawful business for which corporations may be incorporated under Title 30, Chapter 1, of the Idaho Business Corporation act.
