We, J.E. Power, Carrie A. Verick and W.H. Verick, of the City and County of Missoula and State of Montana, do by these presents, pursuant to and in conformity with Chapter 18 of the Act of the Legislative Assembly of the Territory of Montana, passed on the twelfth day of January, one thousand eight hundred and seventy-two, entitled "An act revising, re-enacting and codifying the general and permanent laws of Montana Territory, and the several acts of the said Legislative Assembly amendatory thereof," Associate ourselves together, and form a Company under the name and style of The Garden City Bottling and Liquor Company.

2. The corporate name of said Company is hereby declared to be The Garden City Bottling and Liquor Company.

The objects for which the company is formed are as follows:

2. The objects for which the company is formed are as follows:  
To engage in, and carry on the business of wholesale and retail liquor dealers in all of its various branches, including buying, selling and dealing in all kind o<sup>f</sup> saloon supplies; to buy, sell and deal in cigars and cigarettes; to buy, bottle and sell all kinds of wines, beers and ales; to manufacture and sell all kinds of carbonated goods, and generally to buy, sell and deal in all of the classes of goods usually handled and dealt in by wholesale liquor dealers, and including saloon fixtures and furnishing. Also to purchase and hold real estate and to sell, lease and rent the same. To buy, and hold saloons and saloon fixtures, and to keep, maintain, sell, lease and rent the same.

3. The capital stock of the said Company shall be Fifty Thousand and (\$50,000) Dollars, which shall be divided into Five Thousand (5000) shares of Ten (\$ 10.00) Dollars each.
4. The said Company shall commence on the First day of January in the year one thousand eight hundred and ninety -two and shall continue in existence for the term of Twenty years.
5. The number of trustees who shall manage the concerns of said Company for the first three months shall be three and their names are J.E. Power, Carrie A. Verrick, and W. Verrick, and all residing at the City and County of Missoula, State of Montana.
6. The name of the City, town or locality and County in which the operations of the said Company are to be carried on are City of Missoula, in the County of Missoula and State of Montana.
