**ARTICLE I**

**NAME:** The name of the corporation shall be ABRACADABRA CINEMA MAINTENANCE, INC. OF IDAHO.

**ARTICLE II**

**DURATION:** The duration of this corporation shall be perpetual from the date of filing these articles.

**ARTICLE III**

**PURPOSE:** The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the state of Idaho, as they may be amended from time to time.
