AMENDMENTS TO ARTICLES OF INCORPORATION FOR IDAHO STATE-CIVIC SYMPHONY ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the Articles of Incorporation of the Idaho State-Civic Symphony Association, Inc., are hereby amended as follows:

ARTICLE II

This Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. These purposes include, but are limited by the said Section of the Internal Revenue Code, as follows:

- 1. To foster, promote, develop and encourage in the community an appreciation of the musical arts by promoting and producing, and causing to be produced, musical productions, entertainments and symphonies and by taking part in activities having that end in view.
- 2. To provide incentive for the development of musical talents of students and citizens alike to the establishment of programs and mediums through which they may obtain instruction and practice.
- 3. To bring to the community persons with outstanding musical ability to assist in the presentation of musical entertainment, either in conjunction with a symphony orchestra or with any other activity of the Association.

ARTICLE IX

In the event of dissolution of the Corporation, no member shall be entitled to any distribution or division of the remaining property or its proceeds, and thhe balance of all money and other property received by the Corporation from any source, after the payment of all debts and obligations of the Corporation, shall be used or distributed exclusively for the purposes of the Association within the intent of Section 501(c)(3) of the Internal Revenue Code, as the same now exists or as it may be amended from time to time.

ARTICLE X

The Corporation shall have all powers granted nonprofit Corporations under the laws of the State of Idaho, however, notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organization set forth in Section 501(c)(3) of the Internal Revenue Code under which the Corporation chooses to qualify for exemption, as the same now exists or as it may be amended from time to
