ARTICLES OF INCORPORATION

OF

The undersigned, in order to form a corporation under Chapter 23A.12 of the Revised Code of Washington, hereby signs and verifies the following Articles of Incorporation:

I

The name of the corporation is RETIREMENT INNS OF AMERICA, INC.

TT

The duration of the corporation shall be perpetual.

III

The purposes for which the corporation is organized are to own and operate retirement communities and to transact any or all lawful business for which corporations may be incorporated under the Revised Code of Washington.

τv

The amount of capital stock shall be Fifty Thousand Dollars (\$50,000), and the number of shares shall be Five Thousand (5,000), and the par value per share shall be Ten Dollars (\$10.00).

V

The initial registered office of the corporation is Bank of California Center, Seattle, Washington 98164, and the initial registered agent at such address is J. Stephen Wright.

VI

The number of directors of the corporation shall be fixed as provided in its bylaws, and may be changed from time to time by amending the bylaws as therein provided, but the number thereof shall never be less than 3 nor more than 30. The names and addresses of the directors who shall constitute the Board of Directors of the Company until the first annual meeting of shareholders or until their successors be elected and qualify are:
