## ARTICLES OF INCORPORATION

of

## INSTITUTE CANAL COMPANY.

----

KNOW ALL HEN BY THESE PRESENTS: That we, the undersigned, Edwin Snow, Fern B. Jones, and Maurice H. Greene, all citizens of the United States and natural persons of full age, resident in the State of Idaho, have this day associated ourselves together for the purpose of forming a private corporation under the laws of the State of Idaho, and we hereby adopt the following articles of incorporation:

I.

The name of the corporation is and shall be INSTITUTE CANAL COMPANY.

TT.

The objects and purposes for which, and for any of which, this corporation is formed are as follows:

To acquire, maintain, manage, operate, and control that certain pumping irrigation system in Washington County, Idaho, whereby certain lands adjacent to Weiser, Idaho and known as the Weiser Bench have been heretofore irrigated and to distribute water therefrom among its stockholders; to acquire, own, and dispose of any property in connection therewith and to do any act or thing necessary, expedient, ancillary, or related to its aforesaid general business of a mutual non-profit cooperative canal company.

III.

The term for which it is to exist is fifty years from its incorporation.

The location and post office address of its registered office in the State of Idaho is Weiser, Washington County, State of Idaho.

The total number of its authorized shares shall be eight hundred (800) shares of the par value of one (\$1.00) dollar each.

VI.

Each share of its capital stock shall represent and the certificates evidencing such shares shall indicate that each share represents a one eight hundredth (1/800) interest in the water rights and irrigation works owned by the corporation, and each share of stock shall entitle the owner thereof for use upon his lands for the irrigation thereof and domestic use thereon to his full pro rata share of the water available for distribution from the irrigation works and water supply owned by the corporation, without diminution through increase in the authorized capital stock of the corporation or otherwise.

The number of directors shall be three (3).
