- (2) "To purchase, lease hire or otherwise acquire, hold, own, construct, erect, improve, manage, operate and in any manner dispose of, and to aid and subscribe toward the acquisition, construction or improvement of plants, mills, acquisition, works, buildings, machinery, equipment and factories, works, buildings, machinery, equipment and facilities, any other property or appliances which may appertain to or be useful in the conduct of the business of the corporation;
