ARTICLES OF INCORPORATION CASE AR

JONES SEED COMPANY, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Jones Seed Company, Inc.

SECOND: The period of its duration is perpetual.

The purpose for which the corporation is organized THIRD: is to transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporations Act.

The corporation shall have authority to issue FOURTH: 50,000 shares, all of one class, having a par value of \$10.00 per share.

FIFTH: Winford L. Jones is the name of the initial registered agent in Idaho, and his address, together with that of the registered office of the corporation is Sterling, Idaho 83279.

The number of directors constituting the initial Board of Directors of the corporation is two (2), and the names and addresses thereof are:
