a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the third day of January, 1949,

original articles of amendment, as provided by Section 29-145, 29-147, Idaho Code Annotated, increasing the capital stock to \$500,000.00,

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. 15 of Record of Domestic Corporations of the State of Idaho.

LELAND WAGGONER and G BEN MARTIN, each being separately sworn upon oath depose and say:

That Leland Wagsoner is the duly elected, qualified and acting President, and that C Ben Martin is the duly elected, qualified and acting Secretary; that on December 22, 1948, pursuant to call for a meeting of the stockholders of RARE EARTHS, INCORPORATED issued by the Board of Directors on Movember 20, 1948, and pursuant to a thirty-day written notice of the time, pla ce and purpose of the meeting given to all of the stockholders of said corporation, which notice stated among other things the specific purpose to be to amend Article VI of the Articles of Incorporation of said RANE EARTHS, INCORPORATED, by increasing the total number of shares of stock which the corporation shall have authority to issue to 5,000,000 shares, having a par value of Ten (10¢) Cents each, and amounting in the aggregate to 4500,000.00, AND, FURTHER, to repeal in its entirety Article VIII of the original Articles of Incorporation of RAKE EARTHS, INCOR-FORATED, AND, FURTHER, to amend Article IX of the articles of Incorporation of RARE EARTHS, INCORPORATED, to provide that the shares of stock of said corporation shall not be assessable in any manner or way, by the Board of Directors of this corporation or otherwise.

A meeting of the stockholders of said corporation was duly convened and held, whereas 9,375 shares of the 10,000 shares of

the issued outstanding shares of said corporation were present and represented; that at said meeting by resolution duly presented and unanimously adopted by the affirmative vote of said 9,375 outstanding shares, Article VI of the Articles of Incorporation of MAKE EARTHS, INCORPORATED, a corporation, was amended to read as follows:

"Article VI

That the total authorized number of par value shares of this corporation shall be Five Million (5,000,000) shares, each of the par value of Ten (10¢) Cents, and of the aggregate par value of Five mundred Thousand (ϕ 500,000.00) Dollars, which said shares shall be common stock."

and that Article VIII of the Articles of Incorporation of MARE EARTHS, INCORPORATED, a corporation, was repealed in its entirety, and that Article IX of the Articles of Incorporation of MARE EARTHS, INCORPORATED, a corporation, was anended to read as follows:

"Article IX

That the shares of this corporation shall not be assessable in any manner or way, by the board of Directors of this corporation, or otherwise."

All of which appears upon and is of record in the minutes of said meeting duly recorded in the minute book of said corporation.
