ARTICLES OF AMENDMENT

of

CONCRETE PROCESSORS, INC.


The undersigned, president and secretary of Concrete Processors, Inc., an Idaho corporation, hereby certify that at a special meeting of the stockholders of said corporation, duly called and held at the principal office of said corporation in Idaho Falls, Bonneville County, Idaho, on August 15, 1955, the following resolution was adopted by the unanimous vote of all of the stockholders of said corporation:

"RESOLVED, that Article VI of the articles of incorporation shall be amended to read as follows: The amount of the capital stock shall be \$5,000.00, divided into 5,000 shares, of the par value of one dollar (\$1.00) per share, to be held, sold, and paid for at such time and in such manner as the board of directors may from time to time determine.

RESOLVED, further, that the officers of this corporation be and they hereby are authorized to take the necessary steps to make this amendment effective."

The undersigned further certify that the financial condition of the corporation on the date said resolution was adopted was, as is indicated on the attached schedule, and that the reduction of the capital stock of said corporation by virtue of the aforesaid resolution will not reduce the fair value of the assets of the corporation to an amount less than the total amount of its debts and liabilities plus the amount of its capital stock as so reduced.
