

ARTICLE I. OF INCORPORATION.

Of The Dudley Co-Operative Creamery Company, Limited,
We, the undersigned, desiring to become incorporated under the
provisions of the statutes in such cases made and provided, do
hereby make, execute and adopt the following articles of associa-
tion; to wit:-

Article I.

The name assumed by this corporation, and by which it shall be
known in law, is the Dudley Co-Operative Creamery Company, Ltd.,

Article II.

The purpose or purposes of this corporation are as follows:-
The manufacture and sale of butter, and other dairy products.

Article III.

The capital stock of the corporation hereby organized is the sum
of three thousand dollars, and the number of shares thereof is
sixty.

Article IV.

The number of directors of the corporation herein organized shall
be three in number, and one-third of the directors shall be elected
for a term of one year, one-third for a term of two years and
one-third for a term of three years, and thereafter at each
succeeding annual meeting of the stockholders, one-third thereof
for a term of three years.

Article V.

The operations of this corporation are to be carried on in the
County of Montanal, State of Idaho, and the office for the trans-
action of business, within the state of Idaho, will be kept at
Dudley, Idaho,

Article VI.

The term of existence of this corporation is fixed at fifty years,
unless sooner dissolved, from the date hereof.
