**ARTICLES OF INCORPORATION
(NON-PROFIT)
FOR THE STATE OF IDAHO**

The undersigned, in order to form a Non-Profit Corporation under the Provisions of Title 30, Chapter 3, Idaho Code, submits the following Articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be: Reach Out Incorporated

Article 2: The purpose for which the corporation is organized is: To provide a means by which people (donors) may reach out to help others in need of financial, physical, and/or spiritual help as described in the Bible, with no profit going to any member of the corporation. Following are some examples the corporation may be involved in to meet its purpose: a. Give financial, physical, and spiritual assistance to religious organizations (churches) in Honduras to help the Hondurans involved to develop means and wills to feed poor children with nutritious meals twice a week and give them good dietary and Biblical instruction. The aim is to help Hondurans develop the mindset and habits to help others. b. To help provide food to a poor needy family that comes by our place for help. c. To help set up a small medical clinic in Honduras so that poor Hondurans may receive some needed medical help and give much of the responsibility to other more able Hondurans so they can be assisted in developing the habit of helping or reaching out to others more needy than themselves.


Article 8: Upon dissolution the assets shall be distributed:


