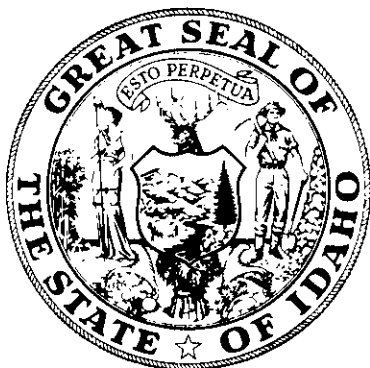

3. The corporation has given notice of its prospective dissolution as required by Idaho Code Section 30-1-87.


4. The corporation's known debts, obligations and liabilities have been actually paid and discharged, or adequate provision has been made therefor.

5. All the property and assets of the corporation have been distributed to the shareholders of the corporation in proportion to their respective rights and interests.


6. There are no suits pending against the corporation in any court.
