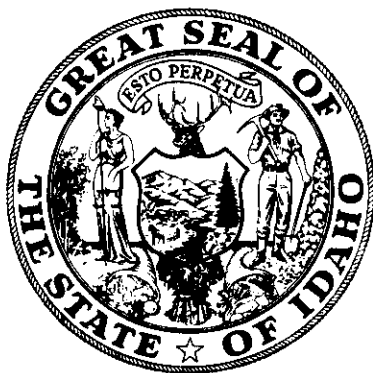

ARTICLES OF INCORPORATION
OF
DEAN L. BESSEY, INC.

The undersigned, acting as incorporator, Dean L. Bessey, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Dean L. Bessey, Inc.

ARTICLE II

The purposes for which said corporation is formed are:

A. Purchase and lease of trucks and trucking equipment and operation of trucking business.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be 1920 Joan, Idaho Falls, County of Bonneville, State of Idaho and the name of its initial registered agent at such address is Dean L. Bessey.
