## Articles of Amendment to Articles of Incorporation of

Gary Schmidt and Priscilla Schmidt, the undersigned, hereby certify that we are, and at all times hereafter mentioned were, President and Secretary, respectively, of Second Church of Christ, Scientist, Boise, Inc. a religious corporation organized and existing under and by virtue of the laws of the State of Idaho, with its registered office and location in Boise, Idaho; that on the 26 day of Jan, 2000 at 8:00 o'clock P.m. of said day, at a meeting of the Board of Directors of said Corporation duly, legally and regularly held, the said Board of Directors determined to present at a special meeting of the members of said Corporation to be held at the office of the corporation at Boise at 7:00 o'clock P.m., on Feb 14, 2000, the matter of considering and voting upon the question of amending Article I of the Articles of Incorporation of the corporation; that pursuant to the direction of said Board of Directors, the Chairman of the Board and the Secretary of the corporation caused public notice of intention to amend the Articles of Incorporation of the corporation to be given by publication at least once per week for four weeks in the Idaho Statesman, a daily newspaper published in Ada County, Idaho and written notice to be provided to the current active members, which notices designated the special meeting at which it was intended to vote on the proposition of amending the Articles of Incorporation and stated the manner in which it was intended to amend said articles, as required by law.

THEREAFTER, pursuant to said notice, on Feb 14, 2000, at 7:00 o'clock P.m., at the office of the corporation at Boise, Idaho the special meeting of the members of said Corporation was held, at which meeting a quorum of members were present in person or represented by proxy; that said members constituted a quorum of members for the transaction of business; that the members present voted unanimously in favor of amending the Articles of Incorporation of this corporation in the particulars hereinafter set out in the resolution adopted by said members; that the following resolution was adopted by a unanimous vote of the members present in favor of said resolution; and that the following is the resolution hereinbefore referred to and adopted by said membership at said special meeting of the above-described vote:

WHEREAS, It is in the best interests of this corporation that the name thereof, to wit, Second Church of Christ, Scientist, Boise, Inc., be changed to Christian Science Society, Meridian, Inc.; now, therefore;

BE IT RESOLVED: That Article I of the Articles of Incorporation of Second Church of Christ, Scientist, Boise, Inc., a corporation, be and the same is hereby amended to read as follows:

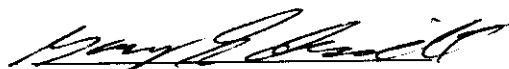

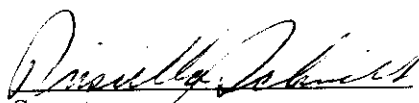
