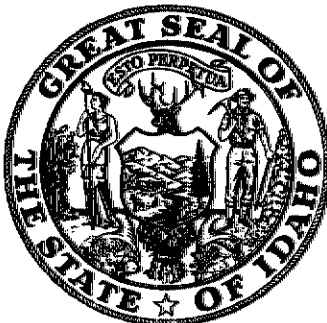

AMENDED AND RESTATED  
ARTICLES OF INCORPORATION

OF  
INTERMOUNTAIN INVESTIGATIONS, LTD.

The undersigned as President and Assistant Secretary of Intermountain Investigations, Ltd., amend and restate the Articles of Incorporation as follows:

ARTICLE I

(Amended effective January 13, 1993)

The name of this corporation shall be Intermountain Investigations, Ltd.

RESTATED ARTICLE II

The purposes for which it is formed is to provide investigative services and to provide for any and all legal purposes and activities for which corporations can be organized.

RESTATED ARTICLE III

The duration of the corporation shall be perpetual.

RESTATED ARTICLE IV

The location of the corporation and its initial registered office is 111 West 15th Street, City of Burley, County of Cassia, State of Idaho 83318. The initial registered agent at such address shall be Douglas R. Whipple.

RESTATED ARTICLE V

AMENDED ARTICLE VI

The total authorized number of shares of this corporation shall be One Million (1,000,000) shares with no par value, all having the same relative rights, preferences, and restrictions on the sale and transfer of the same as set out in the Bylaws of the corporation and any agreement entered into between the corporation and the shareholders.

RESTATED ARTICLE VII

The above named incorporators shall also constitute the initial board of directors of this corporation until the first annual meeting of the stockholders.

AMENDED ARTICLE VIII

Matters pertaining to amendment:

1. The amendments set forth in these Articles were adopted by unanimous vote of the shareholders on February 4, 1995.

2. There are forty thousand (40,000) shares in the

corporation outstanding, all of which are entitled to vote on the amendment and all shares voted for the amendment.

3. The amendment will require that the issued Certificates representing the issued shares of the corporation be exchanged for new Certificates stating the new number of authorized shares of the corporation. This exchange shall take place as soon as the corporation receives a Certificate of Amendment from the Secretary of State.

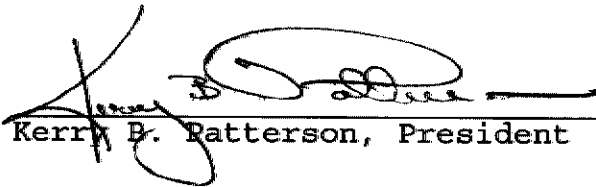
AMENDED ARTICLE IX
