One Thousand Nine Hundred Forty-six and is duly recorded WFSSk No.7 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for fifty (50) years from the date hereof, with its registered office in this State located at Weiser in the County of Washington , and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, Clarence Craven, Clyde Linder and W. E. Myers, all of Weiser, Washington County, Ideho, desiring to form a non-profit, religious corporation under the laws of the State of Idaho, and each being over the age of twenty-one years of age and citizens and residents of Weiser, Idaho, hereby do associate ourselves together for said nursose and do sign, acknowledge and adopt the following articles of incorporation, to-wit:

I.

The name of this corporation shall be "LIBERTY STREET CHURCH OF CURIST, INC."

II.

The names of the persons so hereby associating themselves together for such purpose are: Clarence Craven, Clyde Linder, W. E. Myers, all of whom are residents of Weiser, Idaho.

III.

The principal place of transacting the business of this corporation shall be at Weiser in Washington County, Idaho, with such subordinate places hereafter to be established which such corporation may from time to time determine.

IV.

The general nature of the business to be transacted by this corporation shall be to preach, practice and disseminate the word of God and the teaching of the Bible, to conduct religious worship of all kinds, maintain Sunday schools and in all ways to further and advance all religious teachings and practices and especially the doctrines and teachings of the Church of Christ, and generally to

do and perform all acts and things and execute all papers, contracts deeds, mortgages and other instruments which may be necessary and requisite to carry into effect the objectives of this corporation in the vicinity of Weiser, Idaho; to own, sell, buy and trade for necessary property for church and parsonage and other business requisite for carrying on the purposes and intendments for which this corporation is organized.

٧.

This corporation shall be non-assessable and a non-profit corporation and there shall be no stock and every individual who is a ty Street member of the Liber/ Church of Christ shall be, by virtue of being such member of said church, a stockholder in this corporation and as such shall be entitled to vote and participate at all meetings of the church organization.

The government and management of this corporation shall be vested in a board of three trustees, and Clarence Craven, Clyde Linder and W. E. Myers shall constitute the first board of directors of this corporation and they shall hold their offices until their successors are elected and qualified.

VIII.

The time of the commencement of this corporation shall be the date on which a copy of these articles of incorporation is filed in the office of the Secretary of State of the State of Ideho, and such corporation shall continue to exist thereafter for a period of fifty (50) years.

That attached hereto is a proof of publication of said notice in two issues of the Weiser Signal, showing the publication thereof in the issues of said paper of April 19th and April 26th, 1945, said paper being a legal newspaper published in Weiser, Idaho.

I further certify that at the hour of 7:30 P. M. in the evening of May 6, 1945, a meeting of the members of said Church was held in said church at which meeting a majority of all of the members of said church were present and participated, and at said meeting a board of three members consisting of Clarence Craven, Clyde Linder and W. E. Meyers was elected as the trustees of the Weiser Church of Christ and were authorized be a resolution of a majority of the members to take such steps as may be necessary to incorporate said Church.

RESOLUTION

WHEREAS, the WEISER CHURCH OF CHRIST did, on May 6, 1945, at the Outlook Club building in the City of Weiser, Idaho, elect three (3) trustees and passed a resolution authorizing and empowering said trustees to incorporate such church organization and to act as a board of directors of said Church under the provisions of Section 29-1102, Idaho Code Annotated; and,

WHEREAS, thereafter articles of incorporation were prepared and filed by said trustees so elected and presented to the Secretary of State of the State of Idaho with the necessary fees, and on August 2, 1945 said proposed articles of incorporation were rejected by Ira H. Masters, Secretary of State for the reason and on the grounds that there was already a Church of Christ incorporated at Weiser, Idaho, and had been since January 22, 1910;

NOW, THEREFORE, BE IT RESOLVED that for the purpose of eliminating this conflict between this instant church organization and the one incorporated January 22, 1910, that the Church of Christ, of which the said Clarence Craven, Clyde Linder and W. E. Myers are the trustees, change its name and its name be changed to the

"LIBERTY STREET CHURCH OF CHRIST, INC.

and that the said same trustees be authorized and directed to incorporate said church organization under said name of "Liberty Street Church of Christ, Inc.".
