Know all men by these presents that we Lemuel H.Wells, Bishop of Spokane, Washington, Wm.M.Lane and Jacob Hoover, all of Spokane, Washington, have this day associated ourselves together as a body corporate under the laws of the State of Washington, and do hereby make and adopt the following as the articles of incorporation of the said corporation.

- Art.1. The name of the corporation shall be "The Trustees of the Protestant Episcopal Church in the Jurisdiction of Spokane, Washington.
- Art.11. The location and chief place of business of the corporation shall be the City of Spokane, Washington.
- Art.111. The terms of admission to membership in the corporation shall be as follows: members shall be communicants of the Protestant Episcopal Church and except the Bishop of Spokane Tho shall be a member of the corporation ex-officio, shall be appointed by the said Bishop of Spokane.
- Art.lV. The object and purpose of the corporation shall be to acquire by gift, devise or purchase real or personal property for the use of the said Protestant Episcopal Church of the Jurisdiction of

Spokane, and of all the institutions which are now, or may hereafter be, connected therewith and to hold, manage, lease, improve, sell and convey the same for the benefit of said Church.

Art.V. The officers of the corporation shall be the Bishop of Spokane who shall be ex officio President and a Secretary and a Treasurer who shall conduct the business of the corporation. The Secretary and Treasurer shall be appointed by the said Bishop of Spokane and shall hold their offices for the term of two years and until their successors shall be duly appointed. The trustees to manage the affairs of said corporation shall be three in number and the names of the trustees for the first year of its existence are Lemuel H.Wells, pishop of Spokane Wm.M.Lane, and Jacob Hoover.

Art.V1. The said Bishop of Spokane and his successors in office shall be ex officio a trustee and member of said corporation and the other two trustees after the first year of the existence of said corporation, shall be appointed by said Bishop from these possessing the necessary qualifications and shall hold their offices for the term of two years and until their successors are duly appointed, said appointments to be made on the lst. of January 1894, and every two years thereafter.
