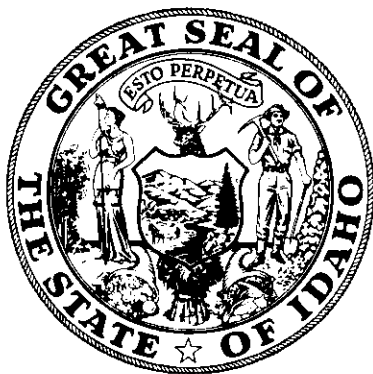

6 WE, THE UNDERSIGNED, Hereby incorporate ourselves  
7 under the Idaho Nonprofit Corporation Act [ §§30-301ff, I.C. ].

9 ARTICLE I

10 The name of the corporation shall be;  
11 BONNEVILLE ECONOMIC DEVELOPMENT CORP.

13 ARTICLE II

14 The corporation is a nonprofit corporation.

17 The duration of the corporation shall be perpetual.

20 The purpose of the corporation is to transact any or  
21 all lawful business for which corporations may be organized under  
22 such act, in the development and promotion of business activities  
23 in Eastern Idaho.

30 office, or at such other place, within or without this state, for  
31 the transaction of any business of the corporation, as the  
32 directors, by resolution or bylaw, might provide; and the name of  
33 its initial registered agent at such address is J. KENT JUST.




