ARTICLES OF INCORPORATION BONNEVILLE ECONOMIC DEVELOPMENT CORP. [\$30-323 I.C.] ///

WE, THE UNDERSIGNED, Hereby incorporate ourselves under the Idaho Nonprofit Corporation Act [§§30-301ff, I.C.].

ARTICLE I

The name of the corporation shall be; BONNEVILLE ECONOMIC DEVELOPMENT CORP.

ARTICLE II

The corporation is a nonprofit corporation.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The purpose of the corporation is to transact any or all lawful business for which corporations may be organized under such act, in the development and promotion of business activities in Eastern Idaho.

ARTICLE V

The address of the initial registered office of the corporation shall be INTERSEC, 1776 Science Center Drive, Idaho Falls, Idaho, 83401, but meetings of the board of directors and of any executive committee thereof, may be held at such registered office, or at such other place, within or without this state, for the transaction of any business of the corporation, as the directors, by resolution or bylaw, might provide; and the name of its initial registered agent at such address is J. KENT JUST.
