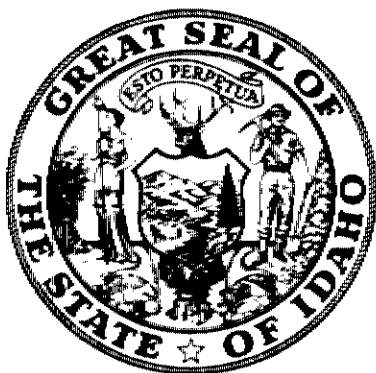

ARTICLES OF INCORPORATION
of the
Moscow - Latah County Economic Development Council, Inc.

We, the undersigned persons, acting as the incorporators of a private, non-profit corporation under the provisions of the Idaho Nonprofit Corporation Act (Title 30, Chapter 3, Idaho Code), adopt the following Articles of Incorporation.

Article I

Name

The name of the corporation is: Moscow - Latah County Economic Development Council, Inc.

Article II

Non-Profit Status

The corporation is a private non-profit corporation.

Article III

Duration

The period of duration of this corporation shall be perpetual.

Article IV

Purposes

This corporation is organized for the following purposes:

- (a) To foster economic development in the Moscow - Latah County area and to receive, administer and expend funds for such purpose;
- (b) To engage in any activity incidental or conducive to the attainment of the purposes of this corporation; and
- (c) To engage in any activity that lawfully may be conducted by a non-profit corporation organized under Title 30, Chapter 3, of the Idaho Code.

Article V

Membership, Election of Officers

All members of the corporation shall serve on the Board of Directors. The initial number of directors shall be eleven (11).

Article VI

Registered Office - Agent

The address of the initial registered office of the corporation shall be 129 West Third Street, P.O. Box 9622, Moscow, Idaho, 83843. The name of the initial registered agent at such address shall be William L. Anderson.
