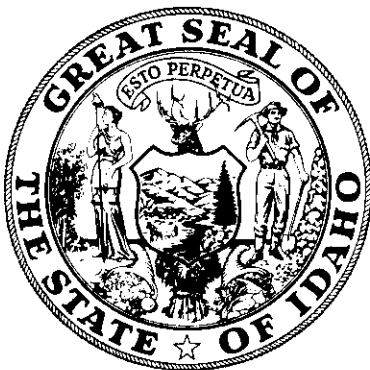

ARTICLES OF INCORPORATION
OF
DEEP CREEK LAND OWNERS COMPANY, INC.

WE, THE UNDERSIGNED INCORPORATORS, hereby associate ourselves together to form a non-profit corporation under the laws of the State of Idaho.

ARTICLE I.

The name of the Corporation is Deep Creek Land Owners Company, Inc.

ARTICLE II.

The location of its principal place of business and registered agent in the State of Idaho is:

and the initial registered agent at said address is Rolene J. Glead.

ARTICLE III.

The term for which is corporation is to exist is ten (10) years.

ARTICLE IV.

The purpose and objects for which this corporation is organized is to negotiate and arrange for the construction of a power line by Utah Power and Light Co. from its lines at the mouth of Deep Creek Canyon to the Last Frontier Estates. In furtherance of this authority, corporation shall have the right and power to borrow money, execute contracts, and own real or personal property.

ARTICLE V.

The initial Board of Directors shall consist of five (5) members which number may be changed by appropriate amendment to the By-laws of this corporation.
