ARTICLES OF INCORPORATION  
OF  
J. D. LUMBER, INC.

Know all men by these presents, that we, the undersigned, being natural persons of full age and at least two thirds of them being citizens of the United States, or of its territories, incorporated or unincorporated, or possessions, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

**ONE:** The name of the corporation is J. D. LUMBER, INC.

**TWO:** The purpose for which said corporation is formed is the transaction of business as a lumber mill, and the transaction of any or all lawful business for which corporations may be incorporated under the Corporation Laws of the State of Idaho.

**THREE:** The corporation is to have perpetual existence.

**FOUR:** The location and post-office address of the registered office of the corporation is Bodie Canyon Road, P.O. Box 55, Priest River, Donner County, Idaho, 83856.
