ARTICLES OF INCORPORATION

OF

YELLOWSTONE BOYS RANCH, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under Chapter 3, Title 30, Idaho Code, and we hereby certify:

ARTICLE I.

That the name of the corporation shall be the YELLOWSTONE BOYS RANCH, INC.

ARTICLE II.

That the purposes for which this corporation are formed are as follows:

- 1. To give boys the opportunity to work.
- 2. To develop social integration and self esteem among boys.
- 3. To enhance citizenship and respect for family and country.
- 4. To provide functional experiences of life situations and conditions whereby youth, through an orientation of the whole self (physical, mental, spiritual, and social), may achieve a well-balanced personality and character.
- 5. To provide an environment and program of educational living which will develop within the individual a sense of honesty, responsibility, kindness, service to God, country, and fellow man.
- 6. To take by purchase, gift, grant, devise, or bequest, and to hold for the use and purposes of this corporation, any real or personal property whatsoever, and to sell, convey, mortgage, lease, or otherwise use the same as may be considered most conducive to the interests and purposes of this corporation.

ARTICLE III.

That the principal place of business activity shall be located in Fremont County, Idaho, and the registered office and agent of the corporation shall be Wayne Richey, whose mailing address is Route #2, Box 114J, Rexburg, Idaho, 83440.

ARTICLE IV.

That the period of existence and the duration of this corporation is and shall be perpetual.

ARTICLE V.

That this corporation and its objects and purposes do not contemplate pecuniary gain or profit to any person or group of persons.

ARTICLE VI.

That this corporation shall have a not less than five nor more than thirty-one Directors in whom shall be vested the corporate powers.

ARTICLE VII.
