That we, the undersigned, being natural persons of full age and citizenship of the United States and of the State of Idaho in order to form a corporation for the purposes hereinafter stated pursuant to the statutes of the State of Idaho do hereby certify as follows:

I

That the name of the corporation is GARY D. JONES CONSTRUCTION COMPANY, INC.

That the purposes for which said corporation is formed is to acquire and own real and personal property, to engage in the general building, acontracting and concrete business and to engage in any and all other allied businesses that may be in any way connected with the general building and construction work.

That the corporation is to have an existance for a period of fifty (50) years.
