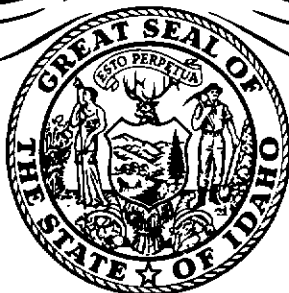

I

That the name of the corporation is GARY D. JONES CONSTRUCTION COMPANY, INC.

That the purposes for which said corporation is formed is to acquire and own real and personal property, to engage in the general building, contracting and concrete business and to engage in any and all other allied businesses that may be in any way connected with the general building and construction work.
