ARTICLES OF INCORPORATION

BAIL BONDS UNLIMITED, INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is Bail Bonds Unlimited, Inc.

ARTICLE TWO

The purpose of the corporation to engage in any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE THREE

The address of the initial registered office of the corporation in the State of Idaho is 2301 15th Avenue, City of Lewiston, County of Nez Perce, Zip Code 83501. The name of the initial registered agent of the corporation at such address is Jackson E. Prim.

ARTICLE FOUR

The total authorized number of par value shares of stock is one-thousand. Each share has an individual par value of one cent (one-hundredth of one dollar). The aggregate par value of the shares is Ten Dollars (\$10.00). There are no authorized shares of stock without par value. The stock of the corporation consists of one class of common stock.
