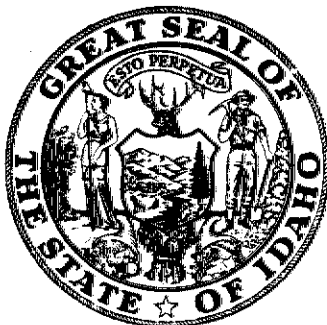

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is Hamco Real Estate & Investments, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are (1) to buy, sell, lease, rent or trade real property; (2) to purchase or acquire by other means real or personal property and to lease, rent, sell or dispose of such property; (3) to acquire by purchase or otherwise stocks, bonds, loans, contracts, leases of corporations or individuals and to exercise all rights, privileges, and functions incident with the ownership of such plus any other thing for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, all of which are to be without par value.
